**THE CHAIR**

A substitute ordinance relating to restricting the issuance of certain temporary food dealer licenses.

68-31-1-c am

This ordinance prohibits an individual with a pending food dealer license application from receiving a temporary food dealer license at the location where the food dealer license is pending, unless the common council member in whose district the food dealer license application is pending has approved the temporary food dealer license application.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 68-31-1-c of the code is amended to read:

**68-31. Temporary Food Dealer License.**

**1. LICENSES.**

c. Application and Issuance. Applications for a temporary food dealer license shall be made pursuant to the procedures set forth in s. 68-21-3 and 4. >>An individual who has applied for, but has not been issued, a food dealer license pursuant to s. 68-21, shall not be issued a temporary food dealer license at the location where the food dealer license application is pending, unless the common council member in whose district the food dealer license is pending has approved the temporary food

dealer license application.<< Licenses shall be issued for the following categories:
