-Analysis-

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

7th Aldermanic District

N. 44th St. - W. Clarke St. to W. Center St. (SW17190338): Relaying combined sewer. (Nonassessable Relief and Relay Sewer Fund -- \$7,000)

8th and 12th Aldermanic Districts

S. 10th St. - W. Lincoln Ave. to W. Harrison Ave. WT41091360 (821-4698-3): Water main alteration. (Nonassessable Water Fund -- \$5,000)

17th Aldermanic District

W. Brown St. - N. 26th St. to N. 29th St. (SW17190337): Relaying combined sewer. (Nonassessable Relief and Relay Sewer Fund -- \$8,000)

All Aldermanic Districts

Sanitary Manhole Rehabilitation (SW17190329): Rehabilitating sanitary manholes. (Nonassessable Relief and Relay Sewer Fund -- \$100,000)

Sanitary Sewer System Flow Monitoring (SW17190335); and, be it

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof.
