THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$101,000 for a total estimated cost of these projects being \$1,051,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$101,000 with the total cost estimated to be \$1,051,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

8th Aldermanic District

S. 23rd St. - W. National Ave. to W. Pierce St. (ST211160109): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$15,000). The total

estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2016 construction season.

10th Aldermanic District

Alley between W. Garfield Ave., W. Lloyd St., N. 51st St., and N. 52nd St. (ST212170104): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2017 construction season.

14th Aldermanic District

Alley between S. Delaware Ave., E. Holt Ave., E. Morgan Ave., and S. New York Ave. (ST212170102): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2017 construction season.

Alley between W. Holt Ave., W. Ohio Ave., S. 11th St., and S. 12th St. (ST212170103): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2017 construction season.

15th Aldermanic District

N. 38th St. - W. Lisbon Ave. to W. Brown St. (ST211010156): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$15,000, Additional Funds). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2017 construction season.

Alley between W. Center St., N. Grant Blvd., W. Hadley St., and N. 41st St. (ST212170101): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2017 construction season.

Various Aldermanic Districts

2015 Scattered sites sidewalk (ST230150150): Laying concrete walk. Doing all necessary grading pertaining to said work. (Nonassessable Sidewalk Reconstruction -- \$31,000). The total estimated cost for this project including the requested amount is \$381,000. This project is anticipated to be completed during the 2015 construction season.

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
