The City cost of the projects approved by this resolution is estimated to be \$215,000. The total estimated cost of these projects is \$230,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

14th Aldermanic District

E. Oklahoma Ave. - S. Ellen St. to S. Kinnickinnic Ave. (WT410091005) File Number 090512: Relay water main. (Nonassessable Water Fund -- \$215,000). The total estimated cost for this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2009 construction season.
