Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

8th Aldermanic District

W. Canal St. Viaduct Drainage Adjustment - W. Greves St. to a point 250 feet west (ST211080150) File Number 080809. Downspouts, grading, construction of a new trap catch basin. (Nonassessable Reconstruction Paving Fund -- \$33,100). The total estimated cost for this project including the

requested amount is \$33,100. This project is anticipated to be completed during the 2008 construction season.
