Substitute resolution appropriating additional funding to the Department of Neighborhood Services from the 2014 Special Purpose Account Reimbursable Services Advance Fund.

Resolved, By the Common Council of the City of Milwaukee, that \$700,000 be and hereby is appropriated from the 2014 Reimbursable Services Advance Fund to the Department of Neighborhood Services to provide additional funding for nuisance garbage clean-up services; and, be it

Further Resolved, That this appropriation is in addition to the \$875,000, appropriated to the Department of Neighborhood Services by Common Council Resolution 130923; and, be it

Further Resolved, That the Department of Neighborhood Services will be reimbursed for nuisance garbage clean-up services from property owners; and, be it

Further Resolved, That the City Comptroller is authorized and directed to establish the necessary accounts and accounting procedures to carry out the intent of this resolution; and, be it

Further Resolved, That the procedures for handling and advancing funds in anticipation of reimbursable revenue be in accordance with those set forth in Common Council File 80-1513.
