Substitute ordinance to further amend the 2004 rates of pay of offices and positions in the City Service under control of the Common Council.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 2 of ordinance File Number 030414 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Grade 007, add the title "Public Health Emergency Response Planning Coordinator."

Part 2. Section 8 of ordinance File Number 030414 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Range 594, delete the footnote designation "4/" following the title "Project Assistant" and delete footnote "4/" in its entirety.

Part 3. Section 19 of ordinance File Number 030414 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2001 - December 24, 2000)

Under Pay Ranges 831, delete the titles "Police Sergeant (Garage)" and "Chief Operator of Police Alarm" and the current biweekly rates of pay and substitute therefor the following biweekly rates of pay. The existing footnotes under these pay ranges are to be retained:

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 8. This ordinance will take effect and be in force from and after its passage and publication.
