Resolution relative to application, acceptance and funding of the Child Care Preventive Health Services Grant.

This resolution authorizes the Health Department to apply for, accept and fund the Child Care Preventive Health Services Grant from Milwaukee Public Schools in the amount of \$85,000. The purpose of the funding is a program that provides health and safety trainings to early childhood care providers serving children.

Whereas, The City of Milwaukee appears to be eligible for grant funds from Milwaukee Public Schools for a program that provides health and safety trainings to early childhood care providers serving children; and

Whereas, The operation of this grant program from 11/01/05 to 09/30/06

would cost \$85,000 entirely provided by the grantor; now, therefore, be it Resolved, By the Common Council of the City of Milwaukee, that application to Milwaukee Publix Schools is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 030712 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2006 Special Revenue-Grant and Aid Projects Fund, the following amounts for the program titled Child Care Prevention Health Services Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amount required under the grant agreement;

3. Establish the necessary project values; and, be it
