Resolution approving a final Certified Survey Map for land located south of West Wells Street and east of North 16th Street to combine three parcels into one parcel and to dedicate land for public street purposes, in the 4th Aldermanic District.

This resolution approves a final Certified Survey Map that combines three parcels into one parcel to create a site for redevelopment and to dedicate public right-of-way in order to accommodate an existing public street. Whereas, The Milwaukee Code of Ordinances (“MCO”), Chapter 119-5, Subdivision Regulations, requires City Plan Commission (“CPC”) approval, conditional approval or disapproval of all Certified Survey Maps (“CSMs”), which provide dedication of land to the City of Milwaukee (“City”) for public purposes; and

Whereas, The City received one final CSM, a copy of which is attached to this Common Council File, which dedicates land to the City for public purposes; and

Whereas, In compliance with the above-referenced chapter of the MCO, CPC has reviewed and approved said CSM; now, therefore, be it
