310-3 am

This ordinance changes the name of the office of environmental sustainability to the environmental collaboration office.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 310-3 of the code is amended to read:

310-3. Environmental Sustainability Director. There is created an ~~[[office of environmental sustainability]]~~ >>environmental collaboration office<< in the department of administration which shall be responsible for the administration, coordination and implementation of the city’s environmental sustainability program. Under the direction of the department of administration, the [[

~~office of environmental sustainability]] >>environmental collaboration office<<~~ shall be administered by an environmental sustainability director. The director of environmental sustainability shall be appointed by the director of administration and confirmed by the common council.
