#### SUBSTITUTE 1

## THE CHAIR

A substitute charter ordinance relating to retirement benefits for certain employes employed by the fire department.

36-03-6-h cr

This charter ordinance establishes that employes employed by the city's fire department under the title of fire cadet are not eligible to be enrolled in the employes' retirement system. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 36-03-6-h of the charter is created to read:

### 36-03. Membership.

6. WHO NOT TO BECOME MEMBERS.
>><u>h. Persons who are employed as fire cadets.</u><</li>

Part 2. This is a charter ordinance and shall take effect 60 days after its passage and

publication, unless within such 60 days a referendum petition is filed as provided in s. 66.0101(5), Wis. Stats., in which event this ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting thereon. <u>APPROVED AS TO FORM</u>
