Substitute resolution relative to acceptance and funding of 2024 Women, Infants and Children's (WIC) Breast Feeding Peer Counseling Grant from the Wisconsin Department of Health Services.

Substitute resolution authorizes the Health Department to accept, and fund the Women, Infants and Children's (WIC) Breast Feeding Peer Counseling grant from the Wisconsin Department of Health Services in the amount of \$162,600 with a City share of \$0 and a grantor share of \$162,600. The funding will provide support and education for new mothers about breastfeeding.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to provide support and education for new mothers about breastfeeding; and

Whereas, The operation of this grant program from January 1, 2024 to December 31, 2024 will cost \$162,600 comprised of \$162,600, or 100%, grantor share and \$0, or 0%, City share; now, therefore, be it;
