Resolution authorizing a sidewalk replacement by City crews at scattered sites in the City of Milwaukee (ST230030117). (Infrastructure Services Division)

To provide the necessary authority for sidewalk repairs at scattered sites in the City of Milwaukee.

Whereas, It is necessary and in the public interest to replace those sidewalk stones which are cracked, broken, out of grade or otherwise a hazard to pedestrians; and

Whereas, It is proposed that sidewalk replacement work be done as requested by City of Milwaukee property owners; and

Whereas, Funds have been encumbered and thus set aside for the proposed public improvement; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works be, and is hereby authorized and directed to proceed to do the above described sidewalk replacement work, and the City Comptroller is hereby authorized and directed to transfer \$200,000 from Account No. 0333-4926-ST230030000 and \$50,000 from Account No. 0330-4926-ST230030000, which is available from Subaccounts; and, be it

Further Resolved, That the proper City departments take such action as is required of them to assess the abutting properties, and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances.
