This substitute resolution amends Common Council file 230952 relative to the 2024 WIC (Women, Infants, & Children) grant from the State of Wisconsin Department of Health Services. The purpose of the grant is to provide enrolled Milwaukee residents with education and support for nutrition, breastfeeding, and shared service enrollment connected to WIC and other State- and City-supported services

Whereas, Common Council File 230952 authorizes the Health Department to accept and fund the 2024 WIC (Women, Infants, & Children) grant from the State of Wisconsin Department of Health Services for the purpose of the grant is to provide enrolled Milwaukee residents with education and support for nutrition, breastfeeding, and shared service enrollment connected to WIC and other State - and City-supported services. This grant provided for a grantor share total of \$1,791,325, and a City

share total of \$0; and

Whereas, the Grantor share for this program is increased by \$205,220; the out-of-pocket City share is increased by \$0; and total cost is increased by \$205,220; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81-5c; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Amend the budgeted funds within the Project/Grant parent account of the 2024 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled WIC (Women, Infants, & Children):
