This substitute ordinance makes positions changes to the following departments: Department of City Development and Police Department, Department of Public Works-Water Works

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 070605 relative to offices and positions in the City Service is hereby amended as follows:

Under "Department of City Development, General Management and Policy Development Decision Unit, Office of the Commissioner", delete one position of "Administrative Assistant IV" and add one position of "Administrative Services Coordinator."

Under "Police Department, Administration Services Decision Unit, Identification Division", delete two

positions of "Document Examiner" and add two positions of "Forensic Video Examiner."

Under "Police Department, Community Services Division, Printing and Stores Section", delete one position of "Printing and Stores Supervisor" and add one position of "Printing, Stores, and Building Services Supervisor."

Under "Department of Public Works - Water Works, Business Organization, Accounting Services Section", delete one position of "Business Operations Manager"; Under "Commercial Services", add one position of "Water Customer Service Supervisor."

Part 2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 3. The provisions of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 4. This ordinance will take effect and be in force from and after its passage and publication.
