Villard Ave. (ST211040109) File Number 020915: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$46,700; Nonassessable Reconstruction Paving Fund -- \$30,000)

Glendale Ave. - N. 26th St. to N. 27th St. (ST211040122) File Number 030748: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$3,700; Nonassessable Reconstruction Paving Fund -- \$25,000)

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances, and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects N. 47th St. (ST211040109), W. Glendale Ave. (ST211040109), and S. 2nd St. (ST211040130) will be billed after January 1, 2007, but not before 12 months after the project contract has been completed; and, be it
