This ordinance increases fees for selected licenses and permits, effective January 1, 2020. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

To compensate for inspectional and administrative costs, a fee of ~~[[ \$100 ]]~~ >> \$175 << may be charged for any reinspection to determine compliance with an order to correct conditions of provisions of the code under the jurisdiction of the department of neighborhood services or assigned to the department, except no fee shall be charged for the reinspection when compliance is recorded. A fee of ~~[[ \$200 ]]~~ >> \$350 << may be charged for each subsequent reinspection. Reinspection fees shall be charged against the real estate upon which the reinspections were made, shall upon delinquency be a lien upon the real estate and shall be assessed and collected as a special charge for payment and settlement as provided in ch. 19 of the city charter.
