Whereas, The law firms of Eggert & Cermele, S.C., and Fuchs, DeStefanis & Boyle, S.C., successfully represented the plaintiffs in a wage suit brought under Wis. Stat. Ch. 109 (Milwaukee County Circuit Court Case No. 02-CV-009910; Wisconsin Court of Appeals Case No. 03-3081); and

Whereas, The plaintiffs ultimately prevailed in that suit and are entitled under Ch. 109, Stats., and the decision to their reasonable attorneys' fees; and

Whereas, The City Attorney's Office has reviewed the fees submitted by the two law firms and agrees that, after reductions, the fee amounts now submitted are reasonable in the following amounts: Eggert & Cermele, S.C., \$67,202.80; Fuchs, DeStefanis & Boyle, S.C., \$11,034.25; now, therefore, be it
