THE CHAIR

A substitute ordinance relating to traffic controls in various Aldermanic Districts. This ordinance establishes the above-mentioned traffic requirements in various parts of the City. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-9-1 of the Code relating to Prohibiting Pedestrian Crossings is amended by adding the following:

On North 6th Street at West McKinley Avenue south crosswalk

Part 2. Section 101-15 of the Code relating Yield signs is amended by striking the following:

"On North 1st Street at East/West Vine Street"

"On North 1st Street at East/West Reservoir Avenue"

"On North 1st Street at East/West Lloyd Street"

"On North Hubbard Street at East Lloyd Street"

"On East Lloyd Street at North Buffum Street"

- Part 3. Section 101-15 of the Code relating to Yield signs is amended by adding the following:
- On South 3rd Street at West Martin Lane
- Part 4. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:
- "On North Hubbard Street at East Garfield Avenue"
- Part 5. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:
- On North Palmer Street at East Vine Street
- On East/West Vine Street at North 1st Street
- On North 2nd Street at West Vine Street
- On North 1st Street at East/West Reservoir Avenue
- On East Brown Street at North Hubbard Street
- On East/West Brown Street at North 1st Street
- On North 1st Street at East/West Lloyd Street
- On North Hubbard Street at East Lloyd Street
- On East Lloyd Street at North Buffum Street
- On East Garfield Avenue at North Hubbard Street
- On North 2nd Street at West Garfield Avenue
- On West Chambers Street at North 81st Street
- On West Warnimont Avenue at West Dodge Place Westbound
