### THE CHAIR

Ordinance relating to the approval of a detailed plan for Phase 3 of a planned development known as Sinai Samaritan Medical Center and to change the zoning from General Planned Development (GPD) to Detailed Planned Development (DPD), lands located east of North 14th Street between West State Street and West Kilbourn Avenue, in the 4th Aldermanic District. (Department of City Development) - Analysis -

Passage of this ordinance will permit the development of additional off-street surface parking for Sinai Samaritan Medical Center. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. There is hereby added to the Milwaukee Code a new section to read:

Section 295-810(2)(b).0097.

- (1) In accordance with the provisions of Section 295- 810(1) of the Milwaukee Code relating to the establishment of planned development districts, the Common Council of the City of Milwaukee herewith approves the detailed plan for Phase 3 of a planned development known as Sinai Samaritan Medical Center, a copy of which is attached to this File as Exhibit "A" which is on file in the Office of the City Clerk and made a part thereof as though fully set forth herein.
- (2) The zoning map is hereby amended so as to change from General Planned Development (GPD) to Detailed Planned Development (DPD), the area bounded and described as follows:

Commencing at the point of intersection of the centerline of West State Street and the centerline of North 14th Street; thence South along the centerline of North 14th Street to the centerline of West Kilbourn Avenue; thence East along the centerline of West Kilbourn Avenue to a point on a southerly extension of the east line of vacated North 13th Street; thence North along the east line of vacated North 13th Street and extensions thereof to the centerline of West State Street; thence West along the centerline of West State Street to the centerline of North 14th Street and the point of commencement.

By this action, the Common Council herewith approves the detailed plan for Phase 3 of a planned development known as Sinai Samaritan Medical Center and amends the zoning map to designate the area described above as a Detailed Planned Development (DPD).

(3) The requirements set forth in said detailed plan attached to this File as Exhibit "A" constitute the zoning regulations for the area contained in such planned development district herein described. Provided further, that the effect of the approval of such detailed plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in such detailed plan.

Part 2. Any persons, firm, company or corporation owning, controlling, or managing any building or premises wherein or whereon there shall be placed or there exists anything in violation of the terms of this ordinance; or who shall build contrary to the plans or specifications submitted to and approved by the Commissioner of Building Inspection, or any person, firm, company or corporation who shall omit, neglect or refuse to do any act required in this ordinance shall be subject to the penalties provided in Section 200-19 of the Milwaukee Code of Ordinances.

Part 3. In accord with the provisions of Section 295- 814(4) of the Milwaukee Code, the City Clerk shall transmit a facsimile copy of the detailed plan and a certified copy of the action taken thereon by the Common Council in recordable form to the Department of City Development for recording of said plan and Common Council action in the Office of the Register of Deeds.

Part 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof. The Common Council hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause, phrase or portion thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases or other portions be declared void or invalid.
