Substitute resolution relative to the application, acceptance and funding of the 2007 Infertility Prevention Grant.

This resolution authorizes the Health Department to apply for, accept and fund the Infertility Prevention Grant from the Wisconsin Division of Health and Family Services in the amount of \$32,899. The purpose of the project is to reduce infertility and the incidence and complications of sexually transmitted diseases through preventive health education services and focused disease intervention activities.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Division of Health and Family Services to reduce infertility and the incidence and complications of sexually transmitted diseases through preventive health education services and focused disease intervention activities; and

Whereas, The operation of this grant project from 01/01/07 to 12/31/07 would cost \$32,899 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Division of Health and Family Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 030712 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2007 Special Revenue Grant and Aid Project fund, the following amount for the project titled Infertility Prevention Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amounts required under the grant agreement; and, be it

1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
2. Expend from the 2007 grant budget for training and out-of town travel for staff;
3. Expend from the 2007 grant budget for equipment as specified in the grant budget; and, be it
