A substitute ordinance relating to the composition and staffing of the capital improvements committee.

320-49-2-b rc 320-49-5 am

Current code designates the commissioner of public works or the commissioner's alternate as chair of the capital improvements committee. This ordinance places responsibility for selecting the chair of the committee under the purview of the common council president.

Current code specifies staff for the capital improvements committee shall be provided by the capital improvements administration, headed by a program coordinator, who shall be selected by the committee and operate under the administrative direction of the committee. This ordinance delineates additional administrative support for the committee, said support to be provided by the city clerk's office.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 320-49-2-b of the code is repealed and recreated to read:

320-49. Capital Improvements Committee.

2. COMPOSITION. b. The common council president shall designate the chair of the committee.

Part 2. Section 320-49-5 of the code is amended to read:

5. STAFFING. Staff for the capital improvements committee shall be provided by the capital improvements administration, headed by a program coordinator who shall be selected by the committee under applicable city service rules, and operate under the administrative direction of the committee. Salaries required for the capital improvements administration, along with supporting supplies, equipment and administrative costs shall be provided annually out of capital improvement funds. >><u>The city clerk's office shall provide administrative support to the committee.</u><< All city departments and agencies shall cooperate with the committee and provide assistance whenever the committee so requests.
