Resolution relating to expenditure of funds to be reimbursed by greater than anticipated revenue. (Debt Service Fund-Bonded Debt - principal)

This resolution provides additional appropriation for the payment of principal on general obligation debt financed from the General Fund as an operating transfer. General Obligation Cash Flow Promissory Notes Series 2013 R1 and EMCP Notes 2012 T8 were issued for the purpose of financing the City's operating budgets on an interim basis in anticipation of the receipt of State shared revenue.

Whereas, The City of Milwaukee issued General Obligation Cash Flow Promissory Notes, Series 2013 R1 and EMCP Notes 2012 T8 to finance the City's operating budgets on an interim basis in anticipation of the receipt of State shared revenue in the General Fund; and

Whereas, the General Fund has received State shared revenues and recorded an operating transfer out of the General Fund equal to the principal due on the debt; and

Whereas, Generally Accepted Accounting Principles require that General Obligation Debt be recorded in the Debt Service Fund, with an operating transfer from the General Fund; and

Whereas, The Comptroller has certified greater than anticipated revenue in the amount of \$200,000,000.00 from State

shared revenue, pursuant to s. 304-91; and

Pursuant to s. 304-91, I hereby certify that the money required for this is anticipated to be realized on or before 12/31/13 and to be expended only for the purpose in this resolution.
