A substitute ordinance relating to recordkeeping and transaction records reporting by secondhand dealers.

92-2-6-d am

92-12-3-a-3 cr

Code provisions require secondhand dealers to maintain and report a record of items received for resale, including color photographs or color video recordings of items consigned, exchanged or sold without a unique serial or identification number permanently engraved or affixed.

This ordinance extends the requirement for maintaining and reporting photographs or video recording to items placed on sale for \$10 or more, including tools, electronic devices and musical instruments with or without unique serial or identification numbers permanently engraved or affixed.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 92-2-6-d of the code is amended to read:

**92-2. Secondhand Dealer's License.**

**6. REGULATIONS.**

d. Transaction Record Reporting. Every secondhand dealer, regardless of whether items are purchased or exchanged on or off the dealer's premises, or consigned for sale on the dealer's premises, except purchases and exchanges of secondhand clothing and clothing accessories, shall report transaction description records as stipulated in s. 92-13>>, including color photographs and color video recordings as required in s. 92-12-3<<.

Part 2. Section 92-12-3-a-3 of the code is created to read:

**92-12. Transaction Description Record.**

**3. Photographs. a.**

a-3. Every item or property received by a secondhand dealer, except clothing and clothing accessories, to be placed on sale at a price of \$10 or greater and including but not limited to tools, electronic devices and musical instruments, with or without unique serial or identification numbers permanently engraved or affixed thereto.
