This resolution designates Friedens Evangelical Church, a/k/a Free Spirit Missionary Baptist Church, 1234 West Juneau Avenue, as an Historic Structure.  
Whereas, The Milwaukee Historic Preservation Ordinance, Section 308-81 of the Milwaukee Code of Ordinances, as amended, provides that Historic Sites, Structures and Districts may be designated by the Common Council of the City of Milwaukee upon the recommendation of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission recommends that Friedens Evangelical Church, a/k/a Free Spirit Missionary Baptist Church, 1234 West Juneau Avenue, be

designated as an Historic Structure; and

Whereas, This structure possesses integrity of location, design, setting, materials, workmanship and association and fulfills the following criterion set forth in Section 308-81(2)(e):

e-4. Portrays the environment of a group of people in an era of history characterized by a distinctive architectural style.

e-5. Its embodiment of the distinguishing characteristics of an architectural type or specimen.

e-6. Its identification as the work of an artist, architect, interior designer, craftsperson or master builder whose individual works have influenced the development of the City of Milwaukee, State of Wisconsin or of the United States.

e-9. Its unique location as a singular physical characteristic, which represents an established and familiar visual feature of a neighborhood, community or the City of Milwaukee.

; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that Friedens Evangelical Church, a/k/a Free Spirit Missionary Baptist Church, 1234 West Juneau Avenue, and further described as follows:

Subd of Part of Lot 6 in Partition of SE 1/4 SEC 19-7-22 Block 24 lots 6 & 7 & lands Adj on W Beg SW cor SD Lot 6 - Th W 75' - Th N 96' - Th E 75' Th S 96' to Beg.

be designated as a Milwaukee Historic Structure. The Preservation Guidelines pursuant to the Historic Designation Study Report, a copy of which is attached to this Common Council File, shall apply to this structure and are adopted by the Common Council as part of this resolution.
