A substitute ordinance to further amend the 2020 offices and positions in the City Service.

This substitute ordinance changes the offices and positions in the following departments:
Assessor’s Office, City Attorney, Health Department, Department of Public Works (Operations Division - Fleet Services)

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Part 1, Section 1 of ordinance File Number 190614 relative to offices and positions in the City Service is hereby amended as follows:

Under “Health Department, Office of the Commissioner & Health Administration”, add the following:

“Auxiliary

Personnel Payroll Assistant III 4”

Under “Clinical Services Division”, add the following:

“Auxiliary

Administrative Assistant III 1
Emergency Operations Director 1
Disease Intervention Specialist- Contact Tracer & Investigator 210
Disease Intervention Specialist Coordinator 15
RN Supervisor and Case Investigator 75
Microbiologist 3”

Under “Community Health Division”, add the following:

“Auxiliary

Administrative Assistant III 1
Temporary Public Health Aide 12”

Under “Environmental Health Division”, add footnote designation "(VV)" to one position of “Deputy Commissioner of Environmental Health (X)(Y)” and add footnote “(VV)” to read as follows:

“(VV) To expire 10/10/20 unless the Advancing Healthier Wisconsin Endowment: Stop COVID-19 grant is extended.”

Under “Policy, Innovation & Engagement Division”, add the following:

“Auxiliary

Health Marketing Specialist 1
Public Health Strategist 7
Graphic Designer II..... 1
Epidemiologist 7
Data and Evaluation Coordinator 3”

Under “Health Strategy Division”, add footnote designation "(VV)" to one position of “Health Strategy Director (I)(X)(Y)”, and add footnote “(VV)” to read as follows:

“(VV) To expire 10/10/20 unless the Advancing Healthier Wisconsin Endowment: Stop COVID-19 grant is extended.”

Part 2. Part 1, Section 1 of ordinance File Number 190614 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 14, 2020 - June 28, 2020):

Under “Assessor’s Office, Systems and Administration Division”, delete two positions of “Office Assistant III”, add one position of “Office Assistant IV”, and add one position of “Office Assistant II”.

Under “City Attorney”, add one position of “Special Deputy City Attorney (Y)”.

Under “Legal Division”, delete one position of “Assistant City Attorney V (A) (Y)”.

Under “Department of Public Works - Operations Division, Fleet Services Section”, add one position “Fleet

Acquisition Manager (X) (Y)".

Under "Operations Dispatch", delete one position of "Fleet Training Supervisor".

Under "Health Department, Community Health Division, Maternal and Child Health", add one position of "Doula Program Coordinator".

Part 3. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 4. The provisions of Part 2 of this ordinance are deemed to be in force and effect from and after Pay Period 14, 2020 (June 28, 2020).

The provisions of this ordinance are deemed to be in force and effect from and after its passage and publication.

Part 5. This ordinance will take effect and be in force from and after its passage and publication.
