Resolution relating to the acceptance and expenditure of the Metropolitan Medical Response System grant.

This resolution authorizes the Fire Department to accept and expend the Metropolitan Medical Response System grant (MMRS) awarded by the U.S. Department of Homeland Security. This resolution continues funding for one position of MMRS Coordinator and provides funding for essential tactical emergency medical services training costs and equipment required to prepare for and

manage incidents resulting from domestic terrorism. The 2013-14 grant award totals \$267,608. Whereas, The U.S. Department of Homeland Security awarded grant funds to Metropolitan Medical Response System (MMRS) jurisdictions to enhance their preparedness in the event of domestic terrorism and mass casualty incidents; and

Whereas, As designated by the Federal Department of Homeland Security, only the cities of Milwaukee and Madison are eligible to apply for these funds; and

Whereas, The Fire Department would use the grant funds to continue one position of MMRS Coordinator and purchase essential supplies and equipment required to prepare for and manage incidents resulting from domestic terrorism; and

Whereas, The operation of this grant project from 10/1/2013 to 7/31/2014 would cost \$267,608, which is entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Fire Department is authorized to accept the grant without further approval unless its terms changed as indicated in s. 204-81 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2013 Special Revenue Grant and Aid Projects, fund the following amounts for the program/project titled 2013-14 Metropolitan Medical Response System:

Project Amount Grantor share \$267,608.00

2. Create the necessary Grant and Aid Project/Grant and Project/Grant levels, budget against these Project/Grant values the amount required under the grant agreement.

Further Resolved, That these funds are budgeted for the Fire Department, which is authorized to: 1. Expend from the amount budgeted sums for the specified purposes, as indicated in the grant budget, and incur costs consistent with the award date.

2. Expend from the 2013 grant budget funds for the items of equipment as may be deemed necessary for the effective operation of the program.
