Resolution authorizing the Commissioner of Public Works to issue an excavation permit on pavement less than three years old in the 200 block of East Capitol Drive for the purpose of installing, at no cost to the City, a new water lateral. (DPW)

- ANALYSIS - This resolution authorizes the Commissioner of Public Works to issue an excavation permit on pavement that is less than three years old.

Whereas, Mid City Plumbing & Heating, Inc. wishes to install a new water lateral at 225 East Capitol Drive; and

Whereas, An open cut method of installation is required in East Capitol Drive; and

Whereas, This open cut will affect pavement less than three years old and subject to a pavement guarantee; and

Whereas, Mid City Plumbing & Heating, Inc. desires to install this new lateral prior to the expiration of the pavement guarantee date in order to complete the construction of a new Aldi Food Store; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is hereby authorized and directed to issue an excavation permit to allow the installation of a new water lateral in the guaranteed pavement in East Capitol Drive; and, be it

Further Resolved, That the pavement restoration of the affected street shall be accomplished in accordance with the specifications and restrictions established by the Department of Public Works of the City of Milwaukee and at no cost to the City. DPW
