ALD. STAMPER

A substitute ordinance relating to the change in zoning from Industrial-Light, IL2, and Industrial-Heavy, IH, to Industrial-Mixed, IM, for the redevelopment of properties located on the north side of West Center Street, east of North 33rd Street, in the 15th Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as

follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

The zoning map is amended to change the zoning for 2727 North 32nd Street, Tax Key No. 309-0502-000; 2748 North 32nd Street, Tax Key No. 309-1206-000; 2758 North 33rd Street, Tax Key No. 309-0503-000; and 3212 West Center Street, Tax Key No. 309-1208-000, from Industrial-Light (IL2) and Industrial-Heavy (IH) to Industrial-Mixed (IM).
