THE CHAIR

A substitute ordinance relating to parking controls.

This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-2 of the Code relating to No Stopping is amended by adding the following:

On the south side of West Manitoba Street from South 13th Street to a point 65 feet west

On the east side of North 85th Street from a point 100 feet north of West Greenbrook Drive to a point 300 feet north thereof from 7:00 AM to 4:30 PM on school days except buses

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

"On West Clayton Crest Avenue from South 26th Street to South 27th Street at any time"

"On the north side of West State Street from North 35th Street to North 46th Street at any time"

"On the south side of West State Street from North 35th Street to North 38th Street at any time"

"On the south side from a point 240 feet east of the east curb line of North 40th Street extended, to a point 125 feet further east thereof at any time"

"On the south side of West State Street from the east curb line of North 40th Street extended to a point 100 feet east thereof at any time"

"On the south side of West State Street from North 40th Street to North 41st Street at any time"

"On the south side of West State Street from the west curb line of North 41st Street to a point 800 feet further west thereof at any time"

"On the north side of West Washington Street from South 6th Street to a point 100 feet east at any time"

"On the north side of West Washington Street from South 6th Street to a point 100 feet west at any time"

Part 3. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the north side of West Clayton Crest Avenue from South 26th Street to South 27th Street

On the north side of West Dixon Street from South 67th Street to a point 40 feet west

On West State Street from North 35th Street to a point 230 feet west of North 46th Street

On the north side of West Walker Street from a point 110 feet east of South 6th Street to a point 40 feet east thereof from 6:00 AM to 6:00 PM Monday through Friday

Part 4. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by striking the following:

"On the north side of West State Street from North 46th Street to North 47th Street from 7:00 AM to 7:00 PM except Sunday"

"On the south side of West State Street from North 38th Street to a point 350 feet west thereof from 7:00 AM to 11:00 PM every day except where no parking is in effect"

Part 5. Section 101-27-3-b-1 of the Code relating to Alternate Side Night Parking is amended by adding the following:

On East Otjen Street from South Williams Street to South Lenox Street
