A substitute ordinance restricting the granting of Class "A" retailer's intoxicating liquor and Class "A" fermented malt beverage retailer licenses.

90-4.7 cr

This ordinance codifies a provision contained in resolutions in effect since June 1976, prohibiting the granting of a Class "A" fermented malt beverage retailer license to an applicant for a premises currently licensed as a filling station. The ordinance further prohibits the granting of a Class "A" retailer's intoxication license to a filling station.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 90-4.7 of the code is created to read:

**90-4.7. Restriction on Granting of Class "A" Fermented Malt Beverage Retailer Licenses.**

No Class "A" retailer's intoxicating liquor license or Class "A" fermented malt beverage retailer license

may be granted to an applicant applying for a premises currently licensed as a filling station.

Part 2. Resolution File Number 76-220-a is rescinded.
