Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$6,667,155 for a total estimated cost of these projects being \$8,975,263.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$6,667,155. The total estimated cost of these projects is \$8,975,263.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd Aldermanic District

N. Humboldt Blvd. - W. Clarke St. to W. Center St. (SM495130011) File Number 121332: Combined

sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$108,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2014 construction season.

3rd and 6th Aldermanic Districts

E. Hadley St. - N. Holton St. to N. Humboldt Blvd. (SM495130078) File Number 130688: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$1,200,000). The total estimated cost for this project including the requested amount is \$1,220,000. This project is anticipated to be completed during the 2014 construction season.

N. Pierce St. - E. Hadley St. to E. Locust St. (SM495130042) File Number 130234: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$320,000). N. 56th St. - 225 feet m/l south of W. Wright St. to W. Lisbon Ave. (SM495120112) File Number 130868: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$193,000). The total estimated cost for this project including the requested amount is \$205,000. This project is anticipated to be completed during the 2014 construction season.

N. 57th St. - W. North Ave. to W. Clarke St. (SM495120078) File Number 120702: Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$650,000). The total estimated cost for this project including the requested amount is \$665,000. This project is anticipated to be completed during the 2014 construction season.

N. 58th St. - 325 feet m/l north of W. Meinecke Ave. to W. Lisbon Ave. (SM495110088) File Number 111024: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$290,000). The total estimated cost for this project including the requested amount is \$305,000. This project is anticipated to be completed during the 2014 construction season.

10th and 15th Aldermanic Districts

N. 48th St. - W. Washington Blvd. to W. Garfield Ave. (SM495120102) File Number 121420: Installing new storm sewer and relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$785,000). The total estimated cost for this project including the requested amount is \$800,000. This project is anticipated to be completed during the 2014 construction season.

15th Aldermanic District

N. 45th St. - W. Lloyd St. to W. Lisbon Ave. (SM495120063) File Number 120702: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$178,000). The total estimated cost for this project including the requested amount is \$190,000. This project is anticipated to be completed during the 2014 construction season.

N. 47th St. - W. Clarke St. to W. Center St. (SM495130045) File Number 130362: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$173,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2014 construction season.

W. Janesville Rd. at WE 617 (Vacated S. 111th St.) (WT410140005) File Number 121552: Water main alteration. (Nonassessable Water Fund Budget Line 6410 -- \$25,000). The total estimated cost for this project including the requested amount is \$40,000. This project is anticipated to be completed during the 2014 construction season.
