Whereas, Charnjit Kaur has offered to purchase the Redevelopment Authority of the City of Milwaukee ("Redevelopment Authority") property at 1317-1337 West Atkinson Avenue for assemblage with her adjacent property for commercial development; and

Whereas, On September 21, 2006, the Redevelopment Authority held a Public Hearing on the proposed sale as required by Wisconsin Statutes; and

Whereas, Pursuant to Wisconsin Statutes and as a condition precedent to the sale, lease or transfer of land, the Redevelopment Authority submits herewith a Land Disposition Report describing the terms and conditions of the proposed sale; now, therefore, be it
