This resolution directs the Department of City Development to prepare a resolution which vacates said portion of street in accordance with vacation proceedings under power granted to the City of Milwaukee by Section 66.297(1), Wisconsin Statutes, and Section 81-308-28, Milwaukee Code of Ordinances. This vacation is necessary to eliminate several existing building encroachments.

Whereas, It has been proposed by the Department of City Development that a portion of the West Side of North Humboldt Avenue between the North Side of East Garfield Avenue and the South Side of East North Avenue be vacated pursuant to the provisions of Section 66.297, Wisconsin Statutes; and

Whereas, The vacation of said portion of street is necessary to eliminate several existing building encroachments; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Department of City Development is directed to prepare a resolution to vacate said portion of street in accordance with Section 81-308-28 of the Milwaukee Code of Ordinances. DCD:JRH:vlk
