Substitute resolution relating to City liens against MATA Community Media, Inc. property. This resolution directs the City Clerk, City Attorney and any other relevant City officials to promptly take whatever actions necessary, and execute all documents needed, to release any and all liens against real or personal property owned by MATA Community Media, Inc., previously known as the Milwaukee Access Telecommunications Authority.

Whereas, The City of Milwaukee was granted liens against real or personal property owned by MATA Community Media, Inc. (MATA), previously known as the Milwaukee Access Telecommunications Authority, through MATA’s agreement with the City to provide public access to cable television broadcasting in the City; and

Whereas, The City no longer has any economic interest in real or personal property owned by MATA; and

Whereas, Lacking an economic interest in any real or personal property owned by MATA, the City has no reason to continue to hold any liens against MATA-owned property; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the City shall release any and all

liens against real or personal property of MATA Community Media, Inc., previously known as Milwaukee Access Telecommunications Authority; and, be it

Further Resolved, The City Clerk, City Attorney and any other relevant City officials shall promptly take whatever actions necessary, and execute all documents needed, to release any and all liens against real or personal property of MATA Community Media, Inc.
