Whereas, Mr. and Ms. Richlen are the only property owners adjoining said lot; and

Whereas, The Department of City Development ("DCD") recommends acceptance of the Offer from Mr. and Ms. Richlen which will remove said lot from the City's inventory thereby reducing maintenance costs; and

Whereas, Said lot is being sold in an "as is" condition and the City makes no representations as to soil or subsoil condition; and

Whereas, The City Plan Commission has determined that said lot is surplus to municipal needs; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that said lot is declared surplus, that the Offer from Laurence B. Richlen and Yvonne B. Richlen is accepted, that the Commissioner of DCD, or assigns, is authorized and directed to perform such acts as necessary to carry out the intent of this resolution and that the proceeds from the sale, less a 20 percent disposition cost reimbursement to the Redevelopment Authority of the City of Milwaukee, be credited to the Reserve For Tax Deficit Fund, Account No. 0001-334106.
