Resolution relating to acceptance and funding of 2024 Homeland Security Program Southeast Wisconsin Threat Analysis Center (STAC) Intelligence and Infrastructure Protection Analyst grant. This resolution authorizes the Milwaukee Police Department to accept and fund a 2024 Homeland Security Program Southeast Wisconsin Threat Analysis Center (STAC) Intelligence and Infrastructure Protection Analyst grant from the Wisconsin Department of Military Affairs Wisconsin Emergency Management in the amount of \$91,549 with a city share of \$0 and a grantor share of \$91,549. The purpose of the grant is to improve STAC’s capabilities of prevention, protection, mitigation, and information sharing to prepare for and counter potential acts of terrorism against Wisconsin’s critical infrastructure and communities. The grant will fund an Intelligence and Infrastructure Protection Analyst to perform vulnerability assessments and other data analysis. The grant will also provide funds for training and program supplies.

Whereas, Under AL#97.067, the City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Military Affairs Wisconsin Emergency Management to improve STAC’s capabilities of prevention, protection, mitigation, and information sharing to prepare for and counter potential acts of terrorism against Wisconsin’s critical infrastructure and communities. The grant will fund an Intelligence and Infrastructure Protection Analyst to perform vulnerability assessments and other data analysis as well as funds for training and supplies; and

Whereas, The operation of this grant from 4/01/2024 to 12/31/2024 would cost \$91,549 of which, \$0 would be provided by the city and \$91,549 (100%) would be provided by the grantor; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Police Department shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2024 Special Revenue - Grant and Aid Projects the following amounts for the program/project titled 2024 STAC IP Intelligence Analyst Grant:

2. Create the necessary Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amount required under the grant agreement;

3. Establish the necessary City Share Project Values; and, be it

Further Resolved, That these funds are budgeted for the Police Department, which is authorized to:

1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;

2. Transfer funds within the project budget as long as the amount expended for each specific purpose does not exceed the amount authorized by the budget by 10 percent; and, be it

Further Resolved, That the 2024 Positions Ordinance shall be amended as follows to reflect the change in footnote (Z):
