The purpose of the project is to prevent nutrition-related health problems and to improve the health status of low-income, at-risk pregnant or breast-feeding women, infants and children up to the age of five years. Whereas, Common Council File 111049 authorized the Health Department to apply for, accept and fund the 2012 Women, Infants and Children's Grant from the State of Wisconsin Division of Health and Family Services.
