Resolution requesting permission from the City of Wauwatosa to allow the property located at 2680 North 98th Street to be permanently connected to said City's sanitary sewer and water main, and for rescinding a Common Council of the City of Milwaukee Resolution File Number 64609. (Infrastructure Services Div.)

- Analysis -

This resolution requests that the City of Wauwatosa grant permission for a property in the City of Milwaukee to be permanently connected to a sanitary sewer and water main in said City; said property is currently connected on a temporary basis to the City of Wauwatosa's sanitary sewer and water main.

Whereas, On July 18, 1938, the Common Council of the City of Milwaukee adopted Resolution File Number 64609 granting permission to the owners of the property located at 2680 North 98th Street to be temporarily supplied with sewer and water facilities by the City of Wauwatosa, until such time as the City of Milwaukee constructed its own facilities in North 98th Street subject to the approval of the City of Wauwatosa; and

Whereas, The property at 2680 North 98th Street is located at the boundary line between the City of Milwaukee and the City of Wauwatosa; and

Whereas, On August 2, 1938, the Common Council of the City of Wauwatosa granted permission to the owners of the property located at 2680 North 98th Street to temporarily connect to the Wauwatosa sanitary sewer and water main in North 98th Street; and

Whereas, The owners of the property located at 2680 North 98th Street have been paying their sewer and water bills to the City of Wauwatosa since 1938; and

Whereas, The City of Milwaukee is proposing to construct sewer and water facilities in North 98th Street from 120'± south of West Center Street to West Center Street, said construction is subject to approval at a public hearing and by the Common Council of the City of Milwaukee; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the 1938 Resolution File No. 64609 be rescinded; and be it

Further Resolved, That the City of Wauwatosa is hereby requested to allow the existing temporary connection of 2680 North 98th Street (Tax Key No. 334-9991-000) to become permanently connected to said City's sanitary sewer and water main; the City of Wauwatosa by this action does not hold itself out to provide water service to any other customers beyond its contract boundaries; and be it

Further Resolved, That a certified copy of this resolution be forwarded to the City of Wauwatosa.
