Resolution relative to application, acceptance and funding of a Sexually Transmitted Diseases Grant. (Health Department)

This resolution authorizes the Health Department to apply for, accept and fund a Sexually Transmitted Diseases Grant project from the Wisconsin Division of Health and Family Services in the amount of \$113,028 with a city share of \$26,178 and a grantor share of \$86,850. The purpose of the project is to reduce the incidence and complications of sexually transmitted diseases through preventive health education services and focused disease intervention activities.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Division of Health and Family Services to reduce the incidence and complications of sexually transmitted diseases through preventive health education services and focused disease intervention activities; and

Whereas, The operation of this grant project from 01/01/98 to 12/31/98 would cost \$113,028 of which \$26,178 (23%) would be provided by the city and \$86,850 (77%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Division of Health and Family Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Encumber in the parent accounts of the 1998 Special Revenue Accounts-Grant and Aid Projects, the following amounts for the project titled Sexually Transmitted Diseases Grant:

Account No. 15-010-0100 Account Share \$86,850
15-010-0101 In-kind City Share \$26,178
15-010-0102 Out-of-Pocket City Share \$(Current Levy)

- 2. Create a Special Revenue Fund Grant and Aid Projects and the necessary expenditure and revenue accounts; appropriate to these accounts the amount required under the grant agreement and transfer the corresponding offsetting estimated revenue;
- 3. Establish the necessary grant performance submeasures; and, be it

Further Resolved, That these funds are appropriated to the Health Department which is authorized to:
