THE CHAIR

Substitute resolution authorizing settlement and cancellation of the City of Milwaukee's subrogation claim against Edward M. Stenzel for payments made pursuant to the City's Basic Health Plan.

This resolution authorizes the settlement of a subrogation lien arising under the City's Basic Health Plan in the lawsuit entitled Edward M. Stenzel, et al. v. Patricia E. Gaber, et al., Milwaukee County Case No. 02-CV-011658.

Whereas, The above-captioned case concerns a personal injury action; Milwaukee County Case No. 02-CV-011658, seeking compensation for injuries sustained by plaintiff Edward M. Stenzel in an automobile collision which occurred on July 22, 2001; and

Whereas, The City has a subrogation claim of \$13,804.60 for medical payments made pursuant to its Basic Health Plan on behalf of Edward M. Stenzel for treatment of injuries allegedly sustained in connection with the accident; and

Whereas, Plaintiff has offered the City the amount of \$9,203.07 in settlement of its subrogation claim;

Whereas, The amount offered is a fair and reasonable settlement of the City's subrogation claim; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that an authorized representative of Wisconsin Physicians Service Insurance Corporation, the claims administrator for the Basic Health Plan, be and hereby is authorized and directed, on behalf of the City, to accept the settlement of \$9,203.07 in release and satisfaction of the City's subrogation claim against Edward M. Stenzel and to execute any necessary stipulations and releases to effectuate this settlement.
