THE CHAIR

Ordinance relating to the change in zoning from Multi-Family Residence (R/B/60) to Parking (P/D/40), on land located on the North side of West Capitol Drive and East of North 7th Street, in the 6th Aldermanic District. (DCD)

- Analysis -

This ordinance will permit parking for Messmer High School.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-610(4).0006. The zoning map is amended to change the zoning for the area bounded by the centerline of North 7th Street, the section line of West Capitol Drive, the centerline of North 6th Street, and a line 120.00 feet North and parallel to the north line of West Capitol Drive, from Multi-Family Residence (R/B/60) to Parking (P/D/40).
