Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

W. Eggert Pl. - N. 45th St. to N. 46th St. (WT410060007) File Number 041695: Relay water main. (Nonassessable Water Fund -- \$70,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2006 construction season.

W. Eggert Pl. - N. 47th St. to N. 48th St. (WT410060005) File Number 041695: Relay water main. (Nonassessable Water Fund -- \$65,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2006 construction season.
