This resolution authorizes payment of the settlement amount agreed to in the lawsuit entitled Verda Jackson, et al. v. City of Milwaukee, et al. in the amount of \$257,500.00.

Whereas, The Estate of Thomas William Jackson and Verda Jackson filed a lawsuit against the City of Milwaukee, Chief Arthur Jones and eight individually-named Milwaukee police officers, seeking an unspecified amount of damages as a result of the sudden death of Thomas Jackson, which occurred while he was in police custody, on or about April 16, 1997; and

Whereas, The parties have agreed to a total settlement amount of \$257,500.00; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to pay this judgment; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the proper City officers be and are hereby authorized and directed to issue a City check in the amount of \$257,500.00, payable to the order of Cannon and Dunphy, S.C. and Verda Jackson, individually, and as Special Administrator of
