Resolved, By the Common Council of the City of Milwaukee, that in accordance with s. 304-24-4 of the Code, the Common Council hereby accepts a contribution from the proceeds of the dissolution of the Citizens for Norquist campaign fund in an amount together with the personal contribution from Mayor John Norquist and his wife, Susan Mudd, totaling \$375,000; such contribution to be made after June 30, 2002; and, be it
