THE CHAIR

Substitute resolution approving a contract extension for Regional Hazardous Materials Response Team services between the Wisconsin Division of Emergency Management-Department of Military Affairs and the City of Milwaukee.

This resolution authorizes the Fire Department to extend the 12-month contract with the Wisconsin Division of Emergency Management-Department of Military Affairs that operated from July 1, 2012 to June 30, 2013, for a 24-month period from July 1, 2013 to June 30, 2015. The agreement allows the Milwaukee Fire Department to provide Regional Hazardous Response Team services within an area including Milwaukee, Ozaukee, Waukesha and Washington counties and parts of Jefferson County. The department has been providing these services since the adoption of Common Council Resolution File Number 941618, and as extended by Common Council Files 990598, 020318, 050049, 070577, 090121, 110005, 111224 and 120105. Under the terms of the amended contract, the City will be eligible for stand-by costs of up to \$250,211.77 annually.

Whereas, 1991 Wisconsin Act 104 authorized the State Emergency Response Board (SERB) to

contract with no fewer than 7 public entities with Regional Emergency Response Teams to assist in emergency responses to Level A releases in a region of the state designated by the SERB; and

Whereas, Common Council Resolution File Number 941618, adopted February 14, 1995, directed the Fire Department to enter into an agreement with the SERB to provide these services for a geographical area consisting of Milwaukee, Ozaukee, Waukesha, and Washington counties and parts of Jefferson County; and

Whereas, The agreement authorized by Common Council File Number 941618 was extended by Common Council Resolution File Number 990598, adopted July 29, 1999, Common Council Resolution File Number 020318, adopted June 25, 2002, Common Council Resolution File Number 050049, adopted May 20, 2005, Common Council Resolution File Number 070577, adopted September 25, 2007, Common Council Resolution File Number 090121, Common Council Resolution File Number 110005, adopted July 26, 2011, Common Council Resolution File Number 111224, adopted February 7, 2012 and Common Council Resolution File Number 120105, adopted June 12, 2012; and

Whereas, The Fire Department has negotiated an extended contract for Regional Hazardous Materials Response Team services for a 24-month period from July 1, 2013, to June 30, 2015, a copy of which is attached to this file; and

Whereas, The City received notice from the Wisconsin Division of Emergency Management-Department of Military Affairs dated June 28, 2013, a copy of which is attached to this file, extending current contracts in full force and effect until the Wisconsin Legislature's Joint Finance Committee meets in executive session upon the request to approve contract renewals and extension; and

Whereas, The Joint Finance Committee, following an initial objection by one of its members to passive review of the request from the Department of Military Affairs under s. 323.70(6), Wis. Stats., met in executive session under s. 13.10, Wis. Stats., on July 18, 2013, at which time it approved the requested 2-year extension of contracts retroactive to July 1, 2013; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper City officials are directed to execute this contract extension on behalf of the City of Milwaukee, and to take all action necessary and appropriate to fulfill the terms and conditions of the contract.
