THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$15,000 for a total estimated cost of these projects being \$1,177,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$15,000 with the total cost estimated to be \$1,177,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

4th Aldermanic District

N. 9th St. - W. Highland Ave. to W. Winnebago Ave. (TD06784001): Relay combined sewer. The total estimated cost for this project is \$344,000. This project is anticipated to be completed during the 2007 construction season.

N. 10th St. - W. Highland Ave. to W. McKinley Ave. (TD06784001): Relay combined sewer. The total estimated cost for this project is \$176,000. This project is anticipated to be completed during the 2007 construction season.

11th Aldermanic District

W. Oklahoma Ave. - S. 70th St. to W. Lakefield Dr. (WT410080018): Relaying water main. (Nonassessable Water Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$175,000. This project is anticipated to be completed during the 2008 construction season.

15th Aldermanic District

W. North Ave. - N. Sherman Blvd. to N. 45th St. (SM495070113): Relay combined sewer. The total estimated cost for this project is \$230,000. This project is anticipated to be completed during the 2007 construction season.

W. Walnut St. - N. 20th St. to N. 22nd St. (TD05880002): Install combined sewer. The total estimated cost for this project including the requested amount is \$172,000. This project is anticipated to be completed during the 2007 construction season.

N. 21st St. - W. Galena St. to W. Walnut St. (TD05880002): Install combined sewer. The total estimated cost for this project is \$80,000. This project is anticipated to be completed during the 2007 construction season.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
