PUBLIC IMPROVEMENTS

Substitute resolution approving and accepting the granting of an easement and authorizing the proper City officers to execute an easement agreement to the Wisconsin Electric Power Company to relocate electric facilities to accommodate the new Emmer Lane bridge at 1540 West Canal Street.

-Analysis-

This resolution authorizes the proper City officers to accept and execute an easement to the Wisconsin Electric Power Company to install and maintain electric service over, across and under certain City owned land.

Whereas, In order to accomplish this service the Wisconsin Electric Power Company has submitted an easement agreement granting them the

right to enter upon City-owned property near 1540 West Canal Street.

Whereas, The terms of said easement agreement are set out and attached to this file and approved as to content by the City Engineer and as to form by the Office of the City Attorney; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that said easement agreement be and the same is hereby accepted, and the proper City officers be and they hereby are authorized and directed to execute the same on behalf of the City of Milwaukee; and, be it

Further Resolved, That after said easement agreement has been executed by the proper City officers, it shall be returned to the Office of the City Attorney for approval as to execution and proper distribution.
