N. 62nd St. - W. Mill Rd. to 725 feet m/l northwest of W. Mill Rd. (WT430033001) File Number 021413: Water main extension. (Developer Water Fund -- \$100,000)

14th Aldermanic District

S. Ellen St. - 400 feet m/l north of E. Ohio Ave. to 200 feet m/l south of E. Morgan Ave. (WT410031067) File Number 030040: Relay water main. (Nonassessable Water Fund -- \$250,000)
