295-505-4-b-7 am

This ordinance prohibits vehicles greater than 10 feet in height or with more than 6 wheels from parking on lots in single-, 2-family or multi-family districts.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 295-505-4-b-7 of the code is amended to read:

295-505. Design Standards.

4. SITE STANDARDS.

b-7. Maximum Vehicle Length >> Vehicle Height and Number of Wheels<<. No vehicle in excess of 22 feet in length >> or in excess of 10 feet in height or with more than 6 wheels<< may be parked on a lot in a single-family, 2-family or multi-family district.
